6.3 METHODS AND MATERIAL FOR CONTAINMENT AND CLEANUP

Spill or Leak Cleanup Procedures: Sweep up or vacuum spilled toner and carefully transfer into sealable waste container. Sweep slowly to minimize generation of dust during clean up. If vacuum is used, the motor must be rated as dust tight. A conductive hose bonded to the machine should be used to reduce static build up. Residue can be removed with soap and cold water. Garments may be washed or dry-cleaned, after removal of loose toner.
