This is not an effect specific to toner dust but is generally observed when high concentrations of other, slightly soluble dusts are inhaled. The lowest-observable-effect-level (LOEL) was 4 mg/m <sup>3</sup> and the no-observable-effect-level (NOEL) was 1 mg/m <sup>3</sup> in rats. The NOEL was greater than 6 mg/m <sup>3</sup> in hamsters.
